Call for Entry

2025 Kansas Day Exhibition "Kansas Through the Eyes of an Artist"

January 25, 2025 - March 14, 2025 - Exhibit Dates

November 9, 2024 - Entry Deadline

December 3, 2024 - Notification to Artists of Acceptance

January 14, 2025 – January 18, 2025 – Artwork delivered. Work will not be accepted after January 18.

<u>Artwork Requirements:</u> Two and/or three-dimensional original work that thematically represents Kansas. Two-dimensional work shall not exceed 36x36. Work shall be framed or gallery-wrapped with painted edges and have a wire hanger on the back (no sawtooth or French cleats, please). Three-dimensional work may not exceed 14x14 at the base and shall be suitable for pedestal display. Art that has been in a previous "Kansas Through the Eyes of an Artist" exhibition at the Carriage Factory Art Gallery cannot be entered into the jury process.

Entries: Artists may enter up to three artworks. The entry fee will be \$30.00 per artist. The entry fee is nonrefundable. High-definition digital file of original artwork, waiver, and entry form must be submitted to <u>director@carriagefactoryartgallery.com</u> by November 9, 2024. Artists will be notified through email by December 3, 2024 if their work is accepted. Selected work shall be delivered between the dates of January 14, 2025 – January 18, 2025. Work delivered after the deadline will not be exhibited. Judging will occur after the exhibit has been installed. Exhibit will open on January 25, 2025 and shall be on display until March 14, 2025. Prizes and awards will be given and announced on January 25, 2025.

<u>Pricing:</u> All work accepted in the exhibition must be for sale. Artists are responsible for pricing and including the commission on the sale price stated on entry form. The Carriage Factory Art Gallery will receive 40% of each sale, artists receive 60% of sale.

<u>Liability and Responsibilities:</u> Artists retain the liability for accepted artwork. Carriage Factory Art Gallery assumes no liability of artwork during housing or transit.

<u>Delivery and Return of Artwork</u>: Artwork shall be delivered to the gallery January 14, 2025, through January 18, 2025, and shall be picked up March 15, 2025 by appointment. Art may be hand-delivered or shipped. Shipping fees and insurance are the responsibility of the artist. Reusable shipping material and prepaid return shipping labels are required. Unclaimed artwork not picked up within 30 days of exhibit closing will be disposed of in any way that seems fit by the gallery without liability.
